

# WHAT IS THE PROPOSED PLAN?

**Proposed Candidate Protected Area Zones** = No land uses may be permitted. Once protected areas are established under legislation, tourism and other land uses may be permitted through management plans. Cover 23% of the plan area.

The **plan area** does <u>not</u> include Nahanni National Park Reserve or land within community boundaries.





#### **Proposed Special**

**Management Zones** = promote certain types of land use (usually tourism, commercial timber and agriculture) while protecting cultural and ecological features. Mining and oil gas not permitted except Zone 28 (oil and gas permitted). Cover 5% of the plan area.



**Proposed Special Development Zones** = permit most of the five main land use activities under certain conditions that would protect special cultural and ecological features in these proposed zones. Cover 35% of the plan area.

**Proposed General Use Zones** = permit all land uses subject to certain conditions. Cover 24% of the plan area.
