How does the land use plan reflect direction from elders?

A workshop was held with elders in 2004 (Dene Nahodhe) about building a land use plan. The most important message from Dehcho elders is take care of the land, wildlife and water. The Interim Dehcho land use plan respects this direction by identifying where land use activities may take place as well as providing rules and recommendations on how land use activities can reduce impacts. The foundation of the plan is the traditional land use as described by Dehcho elders and hunters. The areas of highest traditional land use became Conservation Zones or Candidate Protected Area Zones. Dehcho elders also wanted to see their language, Dene Zhatie, culture and Dene laws respected and the plan has recommendations on how industry can do this.

In August 2015, our summer student, Megan Antoine, presented a session on land use planning to the annual Dehcho Summer Youth Ecology Camp. In March 2016, we held a successful youth and harvesters workshop at Horn River to update hunters and trappers from the Dehcho communities on the draft plan. We also maintained a public profile throughout the year with the annual mail-out of our 2014-2015 annual report flyer and presentations about the draft interim plan at several territorial and northern land use planning forums.

The biggest achievements were resolving a number of outstanding issues and concluding the Committee's review of a draft interim plan in order to refer the draft plan to the Dehcho Process Main Table. The Committee really is a great example of how three governments can work together to meet the interests of Dehcho residents. This now sets the stage for a review of the draft interim plan by the Parties, preparing for implementation and for the Committee to finalize a draft interim plan in 2016-17.




